4. OPEN FORUM 7.31 – 7.46PM

Mr & Mrs Bissell, Main Road spoke about the hedge outside their neighbour's property and how it seriously interferes with the sightline when exiting in a vehicle from their property. Highways at Hampshire County Council have placed a cultivation order on the hedge but this is now being overgrown by other planting and Hampshire County Council have advised there is nothing further they can do to have this cut back. Mr & Mrs Bissell were advised to contact County Cllr Derek Mellor.

Ms Garrard, Monkswood Crescent spoke about the need for a pedestrian crossing in New Road. New Road is crossed by children going to Bishopswood and Tadley Schools and also the Greenacre and Bo Peeps Nurseries. Children and their parents are finding it increasingly difficult to cross the road due to the volume of traffic between 8.15 and 9.15am. Ms Garrard had letters of support from one of the schools and one of the nurseries and also some parents. Councillors agreed there is a need for some type of crossing here and advised Ms Garrard to contact County Cllr Derek Mellor and encourage everyone concerned to write individually to Hampshire County Council to request some action on this as soon as possible.

6. ELECTRIC CAR CHARGING POINTS

Electric car charging points were discussed following receipt of an email from a resident in Huntsmoor Road who does not have the ability to park outside their property in order to charge an electric vehicle. The Committee acknowledged that there are going to be residents who live in parts of Tadley who will not have the facility to charge their vehicles from their homes, i.e.

parts of Huntsmoor Road, Brookside Walk, Stephens Road, all the flats in Tadley, parts of the Barlow Road estate and more. The Committee considered the following options:

- 1. Granting an easement to the resident so they can drive over Tadley Town Council land and charge their vehicle with all legal costs to be met by the resident. The resident to cover the costs of tarmacing and future maintenance of the access route. Access route to have retractable/lockable bollards.
- 2. Lobby Hampshire County Council and ask them to look at putting at least one charging point somewhere in Tadley that can be used by all residents that wish to purchase and run an electric vehicle. Hampshire County Council has already installed some charge points in the county, however they have not installed any points north of Basingstoke.
- 3. Tadley Town Council to apply for grant funding via the On-street Residential Chargepoint Scheme being run by the Office for Low Emission Vehicles for the installation of 2 public electric car charging points next to the Town Council offices.
