Q.4a & 4b – We agree with the key issues however in reality these do not stack up, for example, 'meeting the borough population's changing needs', the housing need in Tadley is predominantly for 1 and 2 bedroom <u>affordable</u> properties and yet most builds are 3 or 4 bedroom executive properties. Some residents express a preference for bungalows, particularly those looking to downsize and those with physical disabilities. With regards to 'facilitating infrastructure delivery' this is lacking in Tadley too, the water surface drainage in Tadley can no longer cope. During heavy rain we suffer with raw sewerage leaks in several places and the formation of large pools of waters on several of our roads. In addition, mobile phone coverage in the area is very patchy.

Q. 5a - Option 1

Q, **5h** – We would support the introduction of a specific policy to mitigate climate change etc. requirements. This should include grey water harvesting, renewable or low carbon energy systems, green roofs, cycle parking and waste recycling.

Q. 5m – Option 2

Q. 50 – More public EVC points particularly in areas where residents cannot park outside their home to charge their vehicles

Q. 6a – We agree with the list of elements relating to design, however with regard to the importance of greenery etc, within developments, more serious consideration needs to be given to the ongoing maintenance. As it is, Basingstoke & Deane Borough Council struggles to maintain the areas it is already responsible for and as is the trend for management companies to take on this kind of responsibility we know this doesn't work well in practice.

Q. 6j – The Local Plan does not allocate any land in Tadley for the provision of sports facilities.

Q. 7a – We agree with the key elements of the spatial strategy in particular the use of brownfield sites. **Q.** 7m – Given the unique circumstances of Tadley we strongly believe there should not be any more development in Tadley apart from small scale developments of social and <u>affordable</u> housing and shared ownership for local people and these should all be within the existing settlement boundary.

Q. 8I – More efficient broadband and increased mobile phone coverage is needed in Tadley, particularly with the trend towards more working at home.

In addition, mobile phone coverage in the area is very patchy. The potential for Bishopswood Stream to flood should be noted along with the continuation of preventative maintenance.

Promoted Site Document

We strongly object to the recent additions to this document, site references TAD014 and TAD015. These are both outside the existing settlement boundary and we are concerned regarding the effect on the AWE DEPZ. In addition, both sites are near to the SSSI site 'Ron's Meadow', Church Lane and Church Brook are extremely well used by our residents for walking, running and cycling, they provide a quiet and safe area in beautiful countryside which is very important for people's well-being, both physical and mental. The loss of this would be extremely detrimental to our community.

Areas suffering from poor surface water drainage are:

Sandford Road, Whitedown Road, Barlows Road (within Bishopswood School), Wigmore Road, Newchurch Road, Cedar Close, Silchester Road, Reynards Close, Silverdale Road, Furze Road, Bishopswood Lane (by the golf course and in-between entrances to Sheridan Crescent), junction of New Road with A340 by swimming pool and Heath End Road.
