Proposal: Retrospective change of Class use to Sui Generis for a 10 bed HMO

Comment (9/0/0): Object.

- We don't like to see retrospective planning applications.
- We repeat our request that an Article 4 Direction for HMOs be extended to include Tadley.
- The application form says there are to be 8 car parking spaces whereas the block plan says 9. The area depicted to have the 9 parking spaces on the site plan is inaccurate and does not reflect the actual scale of the site. The garage would not accommodate 2 regular size cars and there is not enough room for 4 parking spaces to the west of the entrance.
- The site plan shows hedging which is in fact a brick wall.
- We ask that a site visit is caried out to see the reality of the site.
- Existing tenants currently park on the road adjacent to the site which causes congestion during school run times and traffic to back up on the A340. There is a lack of public parking on this side of The Green. With up to 20 people living in the property along with only 9 parking spaces on the site, there is going to be overspill parking.
- We note that hedging between the site and the play area adjacent has been removed and question if this was appropriate for a 10 bed HMO site. The hedging acted as screening, previous residents have complained of the noise from the play area.
- We question whether there are sufficient bathrooms for potentially up to 20 people living in the property.
- We echo the request for the provision of a full waste strategy raised by Basingstoke and Deane Borough Council Joint Waste Team.
- The site is within Zone 1 of the AWE Detailed Emergency Planning Zone.
- Overdevelopment of the site

- Local GPs and dentists are already overstretched and are full to capacity.
 No further development should take place in Tadley until the current issues with storm water drainage are addressed.
- Disappointed to see there is no provision for grey water harvesting, renewable or low carbon energy systems, green roofs, EV charging or waste recycling.
